

TERMS AND CONDITIONS “XMAS GAMES” – ROPPENHEIM THE STYLE OUTLETS

1. Organising Entity

The entities **ROPPENHEIM OUTLET SNC** (“Roppenheim The Style Outlets”), registered with the Nanterre Trade and Companies Register under Siret number 808 263 909 000 34, with its registered office at 121 Rue d'Aguesseau, 92100 Boulogne-Billancourt, and **Neinver, S.A.U.** (“Neinver”), with tax identification number A31038136, registered office at Avenida Pío XII 44, 2nd Floor, Office Building, 28016 Madrid, Spain, jointly organise the promotion called “**Advent Calendar**” (the “Promotion”), accessible via the website The Style Outlets Roppenheim.

The Promotion consists of a skill-based game in which participants meeting the participation requirements set forth in these legal terms (the “Participants”) may obtain the Prizes indicated in clause 7.

Roppenheim The Style Outlets and Neinver shall be jointly referred to in these Legal Terms as the “Organisers”.

2. Purpose of these Legal Terms

These legal terms (the “Legal Terms”) regulate the conditions of participation in the Promotion and must be accepted and complied with by the Participants.

3. Purpose of the Promotion

The purpose of the Promotion is to promote the brand “The Style Outlets”, the Roppenheim The Style Outlets shopping centre, and the other shopping centres belonging to the same corporate group (listed at [<https://www.neinver.com/portfolio/>]) led by Neinver, as well as to encourage visits to Roppenheim The Style Outlets by offering extra points that can be redeemed through the Style Club loyalty programme.

4. Participants

Any person meeting the following requirements (the “Participants”) may participate in the Promotion:

- i. Be over 18 years of age and not legally incapacitated.
- ii. Not be an employee, intern, or contractor of the Organisers, of any other entity belonging to the same corporate group led by Neinver (see list of entities referred to in clause 3 above), or of any entity involved in the organisation or development of the

Promotion in any way, nor be a direct relative or within the third degree of consanguinity or affinity of any of the foregoing.

iii. Hold a Neinver user account, which allows access to most of the platforms, applications, promotions, and digital services offered by Neinver.

iv. Have accepted these Legal Terms.

v. Not commit fraud, damage the image or reputation of the Organisers, breach any of the provisions set forth in these Legal Terms, or in any way impair the proper functioning of the Promotion.

5. Duration and Geographical Scope

The Promotion will begin on **[1 December 2025] at [10:00] (CET)** and end on **[25 December 2025] at [24:00] (CET)**.

It will be available in Spain, Italy, France, the Netherlands, and Poland.

6. Participation Mechanics

Participants may access the Promotion through The Style Outlets/Factory app or The Style Outlets Roppenheim. To participate, Participants must access the skill-based game and, after accepting the Legal Terms, start playing. The game operates in rounds, as described below:

i. As Participants progress through the game, they will accumulate points.

ii. Participants will start each game round and, at the end of each round, will receive the corresponding points.

iii. Points will be converted into loyalty points that the user may redeem for credit and accumulate in their Style Club wallet. The user may redeem up to a maximum of **450 points during the entire game, equivalent to €15**.

iv. Daily game scores will automatically be converted into loyalty points of the Style Club loyalty programme.

v. Each game has its own scoring system. Some games have a limited number of attempts; once they are exhausted, the highest score will be retained. In the remaining games, the total points earned at the end of the round will count.

Participants will have until **1 February** to redeem the points/credits earned through the Advent Calendar. After this date (1 February), any unused points or credits will expire, and Participants will no longer be able to claim them.

The Organisers specify that the points or credits may be used only within the group of shopping centres belonging to entities of the same corporate group using the “The Style Outlets” brand.

7. Prizes

Subject to compliance with these Legal Terms and obtaining the minimum required score, Participants may earn loyalty points, up to a maximum of **450 points**.

Once points have been redeemed, Participants may not make changes or request monetary compensation equivalent to the value of the loyalty points.

Points may only be redeemed by the corresponding Participant.

8. Participant Licence

As Participants, the Organisers grant Participants a limited, non-transferable, end-user licence to view and use the game and other designs, creative assets, elements, or materials related to the Promotion, in executable form, with no territorial restriction, limited to the duration of the Promotion, and solely to the extent necessary for participation.

Any other use of the game or related assets is strictly prohibited. Participants shall be fully liable for any damages arising from unauthorised use.

9. Taxation

The Prizes awarded in this Promotion are subject to all applicable tax provisions in force at any given time.

Since the value of the Prizes shall not exceed €300, the Organisers are not required to withhold or make any tax payments.

Participants are solely responsible for fulfilling any tax obligations that may arise from receiving the Prizes.

10. Liability

The Organisers, their suppliers, subcontractors, partners, agents, or distributors shall be exempt from any liability for damages or losses, whether physical or otherwise, that Participants may suffer as a result of actions or omissions not attributable to them. In particular, the Organisers shall not be liable for damages caused by partner entities related to any Prize.

The Organisers shall not be responsible for any issues arising from Participants' actions or from failures in electronic communications networks or technologies associated with the Promotion that prevent its normal operation due to causes beyond their control.

11. Filing of the Legal Terms

These Legal Terms will be filed at the **Information Point of Roppenheim The Style Outlets**, where they will be available to all Participants and anyone wishing to consult them. They will also be published on The Style Outlets Roppenheim for the entire duration of the Promotion.

12. Modification of the Legal Terms

The Organisers may make any changes they deem appropriate to these Legal Terms at any time, including, but not limited to, the cancellation, repetition, extension, postponement, or modification of the Promotion or these Legal Terms themselves. Such changes will be duly communicated to Participants through the same channels used to announce the Promotion. The Organisers shall not be required to provide any additional compensation to Participants.

13. Data Protection

Participants' personal data will be processed in accordance with Neinver's Privacy Policy, available at [Privacy policy | The Style Outlets Roppenheim](#). Roppenheim The Style Outlets will not process Participants' personal data nor assume any responsibility in this regard.

14. Acceptance of the Legal Terms

Participation in the Promotion requires acceptance of these Legal Terms.

15. Jurisdiction and Applicable Law

Any disputes arising in connection with the Promotion or these Legal Terms shall be resolved in accordance with Spanish law and before the competent courts, as determined by the applicable regulations.
